- The undergraduate students are not allowed to keep cars, motorcycles and scooters in the hostels. Further, PG/PhD Scholars are also not allowed to keep any four wheelers in the hostel premises.
- All students must carry their ID cards while moving out of the campus and when asked by security personnel, they should produce their ID cards.
- Day scholars and guests are not allowed to stay inside the hostel premises after 7.00 pm.

This will come into force with immediate effect.
